Reggie Cansdale from South Hornell spoke regarding a water/rain issue on a property he owns in South Hornell, board said Highway Superintendent to be informed.


Residents came before Board on a property debris issue on the Airport Road and would like Codes Officer to speak to owner and address this issue. Board would look into the matter and get back to the property owners.
